

THE DISNEY IMAGINATION CAMPUS TEACHERS CELEBRATION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Disney Imagination Campus Teachers Celebration ("Promotion") is sponsored by Disney Destinations, LLC ("Sponsor"), P.O. Box 10000, Lake Buena Vista, FL 32830 and is administered by Clarus Commerce LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION PERIOD:** The Promotion consists of a contest ("Contest") and a sweepstakes ("Sweepstakes"). The Sweepstakes begins at 12:00 PM Eastern Time ("ET") on December 8, 2022 and ends at 11:59:59 PM ET on February 11, 2023 ("Sweepstakes Period"). The Contest consists of a submission period that begins at 12:00 PM ET on December 8, 2022 and ends at 11:59:59 PM ET on February 11, 2023 ("Submission Period") that is followed by a judging period that begins at 12:00 AM ET on February 12, 2023 and ends at 11:59:59 PM ET on March 24, 2023 ("Judging Period"). The Submission Period and the Judging Period are collectively the "Contest Period". The Sweepstakes Period and Contest Period are collectively the "Promotion Period". The Administrator's computer is the official clock of the Promotion.
- 2. ELIGIBILITY:** The Promotion is offered only to elementary, middle, and high school teachers employed in a public or private school, who are legal residents of the fifty (50) United States and the District of Columbia and at least twenty-one (21) years of age, in each case at the time of entry and throughout the Promotion Period. Employees of Sponsor, Administrator, Sponsor's promotional partners, and any of their parent and affiliate companies and advertising and promotion agencies, as well as the immediate family (spouse, parents, siblings and children and their respective spouses, regardless of where they reside) and household members of each such employee, whether or not related, are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Promotion.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit DisneyTeachersContest.com ("Website") and complete and submit the registration information including, but not limited to a valid e-mail address, password (created by the entrant), their first and complete last name (no initials), phone number, street address (no P.O. Boxes will be allowed), city, state and Zip Code, school name where entrant works, school city, school state, school Zip Code, school principal's name, and grade level entrant teaches. Upon completing and submitting the registration information, entrant will receive one (1) entry into the Sweepstakes. **Limit:** Entrant will receive one (1) entry for registering during the Promotion Period.

4. **HOW TO ENTER THE CONTEST:** During the Submission Period, after registering or logging in to the Website, an eligible entrant must then follow the on-screen prompts to submit an essay that describes an example where you brought wonder, creativity and imagination to life in your curriculum that inspired students in new ways to enter the Contest (“Submission”). **All Submissions must comply with the restrictions outlined below.** Sharing or posting of the Submission on social media, including on Instagram, Facebook or Twitter, will not improve your chances of winning. **Entry Limit:** There is a limit of one Submission per person during the Submission Period. If more than one (1) Contest submission is received from the same person, only the first Submission received may be considered valid.

Entry Requirements: All entries must comply with the following restrictions:

- Must be in English, except for commonly understood non-English words;
- Must comply with these Official Rules;
- Essay must not be longer than two thousand five hundred (2500) characters;
- Must not include any identifiable person(s) other than the entrant;
- Must not contain material that violates or infringes another’s rights, including, but not limited to, privacy, publicity or intellectual property rights or that constitutes copyright infringement;
- Must be the original work of the entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by entrant;
- Must not disparage Sponsor or its products or services, Administrator, or any other person or party;
- Must not have been submitted previously in a promotion or contest of any kind and has not been exhibited or distributed currently or previously in any media;
- Must not contain, facilitate, reference, or use material that is fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- Cannot be sexually explicit or suggestive, unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group, profane or pornographic, or contain nudity or any materially dangerous activity;

 - gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Submission was created.

NOTE: If any Submission fails to comply with any of these Entry Requirements or any other provisions of these Official Rules, Sponsor and Administrator reserve the right to disqualify the entrant, at any time.

SUBMISSIONS POSTED TO THE WEBSITE WERE NOT EDITED BY SPONSOR AND ARE THE VIEWS/OPINIONS OF THE INDIVIDUAL ENTRANT AND DO NOT REFLECT THE VIEWS OF SPONSOR IN ANY MANNER. Entrants shall not incorporate any intellectual property owned by a third party into their Submission. Each entrant hereby agrees to indemnify and hold the Contest Entities harmless from and against any and all third-party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of entrant hereunder.

By submitting a Submission, entrant hereby grants permission for the Submission to be publicly posted, at Sponsor's sole and absolute discretion. By submitting a Submission, entrant grants Sponsor an unlimited, worldwide, royalty-free, irrevocable, perpetual, license and right to publish, use, publicly perform and display the Submission in whole or in part, in any way, in any and all media, without limitation, and without consideration to the entrant, for promotional or marketing purposes. The Contest Entities are not responsible for lost, late, stolen, damaged, incomplete, invalid, un-intelligible, garbled, delayed or misdirected entries or Submissions – all of which will be void. Sponsor reserves the right to disqualify any entrant and/or Submission in its sole and absolute discretion.

5. **CONTEST JUDGING PERIOD:** During the Judging Period, the Submissions will be judged by a panel of judges selected by the Sponsor in its sole and absolute discretion ("Judges"). The Judges will score the entries according to the following weighted criteria: (i) Problem Solving & Student Impact: 50%; (ii) Innovation & Creativity: 30%; (iii) Inspires Optimism: 10%; and (iv) Immersive Storytelling 10% ("Judging Criteria").

The one hundred (100) Submissions that receive the highest score will be declared the potential Contest prize winners. The Contest winners are potential winners pending verification of eligibility and compliance with the Official Rules. In the event of any ties, the entry with the highest score in criterion (i) Problem Solving & Student Impact will prevail. In the event there are still any ties, the tied Submissions will be judged again and the Submission with the highest overall score will prevail. If a potential winner is found to be ineligible or does not comply with these Official Rules, or otherwise does not accept their prize as awarded, he/she will be disqualified and the Submission with the next highest judges score will be named a potential winner. Administrator's, Judges', and Sponsor's decisions shall be final and binding in all matters pertaining to the judging and selection of the winners. Judging scores will not be revealed. Sponsor reserves the right to not award the Contest prize if, in its sole and absolute discretion, it does not receive a sufficient number of qualified Submissions.

6. **SWEEPSTAKES RANDOM DRAWING:** On or about February 13, 2023, the Administrator will select one hundred (100) potential Sweepstakes prize winners in a random drawing from all eligible Sweepstakes entries received during the Sweepstakes Period. Each Sweepstakes prize winner is deemed to be a potential winner pending verification of their eligibility and compliance with these Official Rules as determined by Sponsor, in Sponsor's sole and absolute discretion.

- A. **Contest Prizes (100):** Each Contest prize is a trip to *Disneyland*® Resort ("Contest Prize") for winner and up to one (1) guest selected by winner (together, the "Group"). Each Contest Prize includes: (i) one (1) round-trip coach class air transportation between the major United States gateway airport closest to the winner's residence and a Southern California airport as chosen by Sponsor ("Arrival Airport") (for winner only), (ii) up to two (2) round trip ground transfers for the Group between the Arrival Airport and *Disneyland*® Resort (ground transfers to be selected by Sponsor at its sole discretion), (iii) hotel accommodations for the Group (one (1) standard room/quad occupancy, including room tax, subject to certain room availability) for three (3) consecutive nights at a *Disneyland*® Resort or *Disneyland*® Resort area hotel selected by Sponsor in its sole discretion, (iv) up to two (2) 2-day *Disneyland*® Resort *Park Hopper*® Tickets (subject to restrictions), (v) one (1) \$200 Disney Gift Card (terms and conditions apply) (for winner only), and (vi) one (1) ticket for access to the Disney Imagination Campus D100 Teachers event on May 5, 2023 (for winner only). **The Group must travel on May 4, 2023 and return on May 7, 2023, and guest (if any) must travel on the same itinerary as the winner.** The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation, particular hotel selected by Sponsor, whether winner elects to bring a guest, and other factors.
